- II. Review Proposed Judging Format For WCHA Events
  - Proposal to use our most qualified WCHA Judges who can never judge a WCHA event because
    they are in attendance as competitors. Proposal to use them in classes they have no
    conflicts. Falcon presented document for rules of compliance and implementation and stated
    he included this provision with newly revised Judge's Guideline in the event we used at future
    WCHA events.
